- B. For Lot 2 Item No. 1, the warranty was set to 1 year on parts and availability of after sales service.
- C. For Lot 2 Item Nos. 2, the warranty was set to 2 years on parts and availability of after sales service.
- D. For Lot 3 Item No.1, the warranty was set to 1 year on parts and services and availability of manufacturer's trained technician for after sales service.
- E. For Lot 3 Item No.1, all accessories and peripherals should be on the same brand except microphones.
- F. Site Inspection Certificate from the end-user (BIOMECH) for Lot 3 shall be required and submitted by bidders.
- G. The delivery terms was set to 30 calendar days upon receipt of Notice to Proceed.
- H. Each item to be evaluated and compared with other Bids separately and recommended for contract award separately.
- I. All revisions on the technical specifications of the items for bidding shall be reflected in the revised bid form posted in UPLB and PhilGEPS websites.
- J. All eligibility documents submitted shall be arranged accordingly and labeled with page tabs to facilitate orderly and timely checking during the opening of bids.


