## B. Permitting/ Documentation

- 1. Site inspection is required for prospective bidders.
- 2. Register new classified hazardous wastes of UPLB in the hazardous waste management system website including payment of registration and administrative fees.
- 3. Obtain a Permit-to-Transport (PTT) from the DENR EMB including payment of permitting fees.
- 4. All works shall be done in compliance with DAO 36, Series of 2004, otherwise known as the Procedural Manual for Hazardous Waste Management and all applicable regulations.

# C. Environment, Health and Safety

 Follow the standard in hazardous waste management and handling, including the use of the Standard PPE such as safety shoes, goggles, protection coveralls, and gloves. Establish site perimeter and install warning signs as necessary..

- 2. Provide materials, tools, push carts, transportation vehicles, expertise and other related services for performing the collection, treatment, and disposal works.
- 3. Provide secondary containment materials such as plastic drums and steel drums to ensure safe transport of laboratory/ hazardous wastes.
- D. Collection, Transport and Disposal (30 calendar days)
  - The service provider shall consider the road size, condition, and capacity to ensure
    the safe and efficient collection and transport of hazardous waste. For purposes of
    identification, vehicles shall bear the name and telephone number of the service
    provider.
  - 2. A representative from the UPLB-OVCCA must countercheck the quantity of hazardous waste loaded in the trucks.
  - 3. Upon issuance of the PTT, collect transport hazardous wastes to the DENR EMB accredited treatment and disposal facility.
  - 4. Each truck shall be loaded with hazardous waste in a manner that prevents spillage of hazardous wastes within the transport route of the hauling process (enclosed truck shall be used).
  - 5. The SERVICE PROVIDER is responsible for handling and loading the hazardous waste into its own service trucks using appropriate tools, machinery, and equipment.
  - 6. Furnish the UPLB a copy of the Certificate of treatment and disposal stamped and received by DENR-EMB.

#### SPECIAL QUALIFICATIONS:

Prospective bidders should have experience in undertaking similar project with an amount of at least 50% of the Approved Budget for the contract and have key personnel and equipment (owned, leased, and purchased) available for the project.

#### CONFIDENTIALITY AND NON-DISCLOSURE AGREEMENT

The SERVICE PROVIDER and all its personnel involved in the performance of the activities of the contract/undertaking shall be covered by the CONFIDENTIALITY AND NON-DISCLOSURE AGREEMENT.

The SERVICE PROVIDER is hereby prohibited to use or attempt to use any recording device to record the activities of the contract/undertaking. The Provider shall not disclose contents of any documents, materials, or project manuals that would compromise the position of UPLB and must adhere to the provision of RA 10173 or the Data Privacy Act of 2012. The Provider must maintain the information obtained from the UPLB in strict confidentiality.
